# Protect policy ending public export support for coal: France must show leadership five months from the COP21.

Dear Mr President François Hollande,

We are alarmed by a recent issue paper from your government regarding the implementation of your decision to end France's public support for coal exports.

On 27th November 2014, you announced the end of all export support for coal through COFACE. On 4<sup>th</sup> February 2015, the French Prime Minister indicated that such support would be provided only for coal power plants that can capture and store the CO2 they produce (operational CCS plant, not CCS-ready plant).

We and other international civil society organizations warmly welcomed this announcement, even while acknowledging deep concerns about CCS and recognizing the need to keep the vast majority of fossil fuel in the ground, including almost all coal reserves, if the international community's mutually agreed climate change goal is to be achieved.

Given that expanded coal and other fossil fuel use is not compatible with the 2°C internationally agreed climate limit<sup>1</sup>, continued public support for coal with taxpayer money is unacceptable. Export credit agencies' support for coal represents the biggest source of international public finance for coal overseas<sup>2</sup>. A recent OECD report states that even the most advanced (and costly) coal-fired power plants are not going to be consistent with a 2 degree goal unless they can capture and store the CO2 they produce<sup>3</sup>. The G7 and the OECD committed to discuss how to curb public financing for coal overseas in order to fight climate change<sup>4</sup>. It is now imperative that the OECD can finalize its agreement prior to COP21 in Paris. No agreement is likely to be reached if France reverses its progressive position.

We are therefore appalled to learn that the issue paper recently released by your government includes policy proposals that follow the coal industry's approach and fails to make any significant progress

towards addressing the climate crisis. Indeed, some proposals amount to merely banning support for (least efficient) subcritical coal power plants – a technology which Alstom, the only beneficiary of COFACE's support to coal, is stopping to export. This would leave export support for the bulk of the coal market unaffected until 2020 or even 2030. The proposal would therefore not result in any significant and immediate climate benefit.

Five months ahead of COP21 in Paris, it is of utmost importance that France demonstrates leadership on critical mitigation issues such as ending public support for coal overseas – as a first step to end public support for fossil fuels. This is no time to walk back on your iconic decision. On the contrary, this is the time to reaffirm the need to address the climate crisis and to immediately end public support to coal power plants.

We view the issue note as incompatible with the French claim of climate leadership – especially when most of the implementation options that are envisaged by your government would be less ambitious than the weak German position and far behind the US position. These options neglect climate science. They introduce a double standard with the existing Agence française de développement's policy on coal support (no support for coal except for power plants equipped with operational CCS). They undermine the chances of a strong OECD outcome. They also threaten the chances to achieve the agreement we need in Paris.

Mr. President, we urge you to weigh in and reject the proposals for weakening the implementation of your commitment to end export support to coal. We call on you to immediately implement the policy as first announced and welcomed at the international level.
